A Motion to Save the Historical Heritage of the HRFA

Robert H. Boyle's dream eventually became a reality when the Hudson River Fishermen's Association (formed in 1966) launched its *Riverkeeper* boat in 1983.



THEN

The H.R.F.A. created *the world's first* Waterkeeper Organization. The photo above shows the 1983 maiden-launch of its 25-foot wooden boat tasked with patrolling the Hudson for polluters. It was initially piloted by John Cronin.



NOW

Sadly, the original Hudson River Fishermen's Assn's *Riverkeeper* boat lies all but forgotten; rotting away in the woods in Garrison, NY. We would like to refurbish her to her glory days when she became *the world's first* Riverkeeper vessel.

September Meeting Recap

Fisheries biologist Jessica Best shared her areas of research on important species inhabiting the Hudson River. This included the striped bass, shad, herring and blue crab. She explained details on the new Addendum VI under consideration and open to public comment before being added to Amendment 6 of the possible changes to striped bass regulations. See some of her slides in the section below where **Serge Radossi** calls on us to voice our

support of Option 2-A2.

Jessica also manages the [***Hudson River Striped Bass Cooperative Angler Program***](#). Whether you catch-and-release or take home a keeper, you can be part of the Cooperative Angler Program. Share your fishing trip information and help biologists understand and manage our striped bass fishery. You will receive an annual newsletter summarizing the information in addition to the latest news regarding regulations and the river. 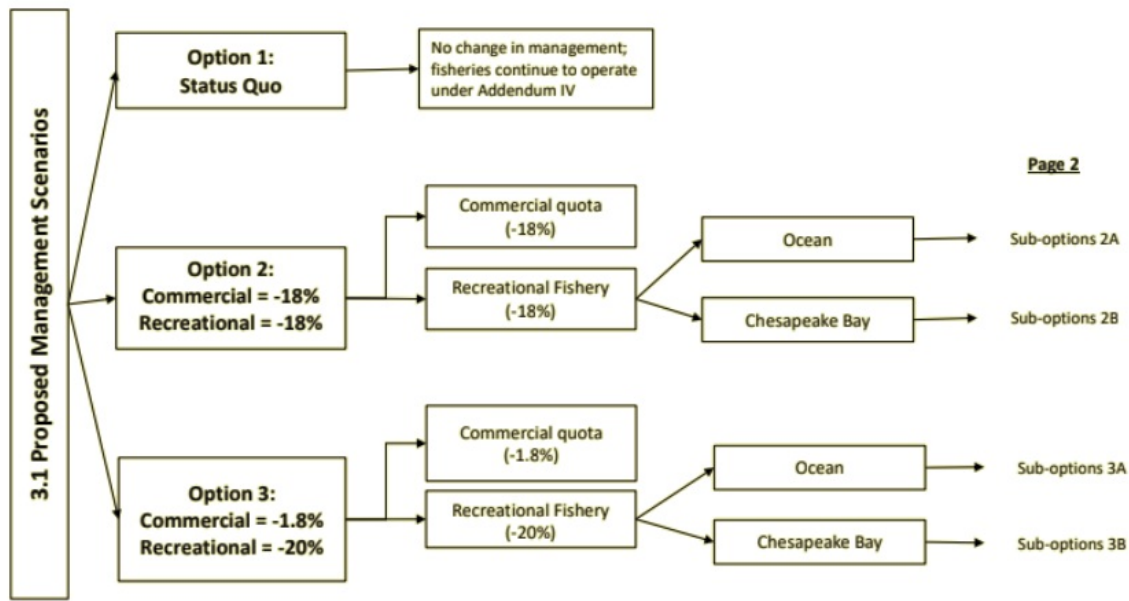
- Fill out a logbook provided by us whenever you fish on the Hudson River (by boat or on the shore).
- Record general location, time, gear used, what you caught (or if you didn't catch anything).
- Return the logbook when you are done fishing.

Carl's Column for October

SEPTEMBER STARTS SERIOUS STREAM SALMON SEASON

Depending on the amount of heavy rainfall the first significant runs of mature coho and Chinook salmon will start appearing in good numbers up the larger streams flowing into the Great Lakes, especially Lake Ontario. The HRFA readership should be primarily concerned with *major tributaries* in the early days because these heavier flows being cold and more consistent have a greater draw on fish in the lake and likely have fish that patterned and instinctively want to return to them

naturally in the first place. Some of the fish were outright released from those rivers and have that strong instinctive imprint to return and in some rare cases there was even natural reproduction all the way from egg to adult. (That can only occur when there is a perfectly cold and consistent environment for the eggs to become fertilized and become parrs and smolts with no drought, heat or parasite factors to wipe out their survival). Fish will still be caught out in the lake by trolling especially at the mouth of all these tributaries where the fish are all gathered to stage.

You have two main options of rod to use that work well. A 7.5 to 9 foot long graphite spinning rod that is top quality and able to take a strong initial run will be essential for the spin fisherman combined with a spinning reel that has a fine quality drag that is smooth as silk for the same reason as above, the surging power run. The angler on a budget can succeed with lower end Shimano and Diawa reels on an Ugly Stick Blank. Better levels and custom gear is something that can run 10 X the cost but still take the same three fish limit. I love using spinning rods I built for myself, plus 8 weight 9 ft. Shu-fly fly rod blanks have provided me with hundreds of happy salmon catches, releases, memories, and hickory smoked delectables.

Stuff you must have to fish streams correctly and thoroughly are the following: A great vest, better yet one that can double as a life vest, to hold your flies, tube of tied egg sacks, swivels, hooks, weights, leaders, license, Chapstick, stringer, (small pine cone to plug female to save eggs for tying egg sacks). Do not forget your hat, top quality polarized sunglasses with neck lanyard, salmon net, cell phone in waterproof wrapping.

If you expect to fish for salmon in creeks, rivers and streams you must have waders with felt bottoms or some type of corkers, spikes, claws, chains, or grips. The flat slimy rocks that make up the bottoms of these running flows are beyond treacherous, they potentially can kill you! Every year people drown who do not heed the warnings and venture forth without wader belts, wading staffs, fishing buddies and a vest that will float if they really get sucked into a problem area. Why not up your odds of survival by taking these simple safety measures to make your adventure a round trip with a happy ending.

I did not mention the type of waders because that varies with the weather and the budget each angler must contend with simultaneously. Top level breathable Gortex light stuff cost in the high hundreds but is comfortable and you can fish for hours without breaking a sweat. I love the old heavy neoprene in the colder October/November salmon to steelhead turnover for the warmth and forgiveness when kneeling streamside to unhook, stringer, or rerig. I know plenty of men who limit out using the classic "RED BALL" "rubbers" they bought for under eighty bucks and with a pair of long johns and two pairs of wool socks, no salmon was safe until after Halloween.(Then they were spawned out rotting ghosts for the most part anyhow!)

A few months back I spoke at the HRFA general meeting with **Scott Havner** on Great Lakes fishing and gave out sheets that identified over a dozen hot spots that might hold fish in Ontario tributaries. Hopefully you grabbed a copy and will make use of this valuable map of hidden "fish treasures". The ambitious angler who rises before dawn and is ready to catch the fish coming up stream early is going to have the element of surprise because that sunrise salmon has not seen a line yet and is hell bent on movement and will strike what gets in his/her way.

I hope hordes of salmon are ready to pounce on your offerings when you wet a line this fall, be it a purple nurple fly, egg sack, or glow Cleo spoon. There are few greater thrills than a majestic salmonid breaking water at double digit poundage and double digit speed and repeating the feat five times until the hook flies back in your face and you get to do it all over again because *that was just your first cast of the day!*

AMENDMENT 6 TO THE INTERSTATE FISHERY
MANAGEMENT PLAN FOR ATLANTIC STRIPED BASS.
Information on how to do this at the end of this e-mail
and in the attachment.

I strongly suggest that the HRFA support sub-option 2-A. This would require an 18% quota reduction in the Hudson River. Given that the Hudson is a significant spawning area it might be a good idea to reduce the catch during spawning season. It is important to note that the Hudson is not considered in the NOAA/MRIP fisheries management models. I would think that spawning areas would be high on the list... but that is typical of NOAA.

Sub-Option 2-A: Ocean Recreational Fishery (All jurisdictions would implement). Under all sub-options, New York would be required to submit a proposal that achieves an 18% reduction in removals relative to 2017 levels for the Hudson River management area, and Pennsylvania would be required to submit a proposal that achieves an 18% reduction in its state waters (catch from Pennsylvania and the Hudson River is not covered by MRIP).

There are 4 further sub section options under 2-A. Option 2-A2 provided for a 28-32" slot size. The theory is to save the larger breeding females.

The final date comments will be accepted is October 7, 2019 at 5:00 p.m. Comments may be submitted at state public hearings or by mail, email, or fax. 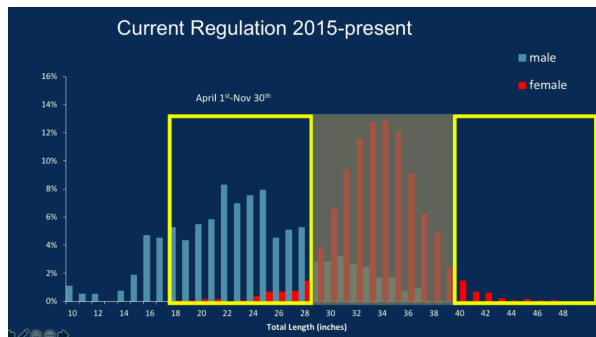

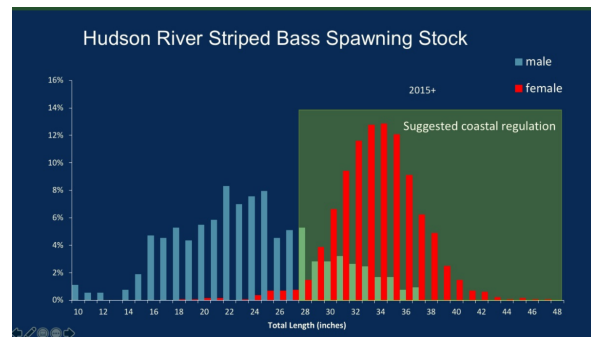

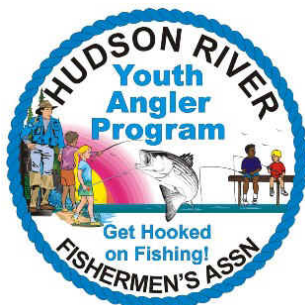


Current regulations. Focuses on protecting the majority of the spawning females while still permitting an angler to harvest a trophy striper. Slide courtesy of Jessica Best.

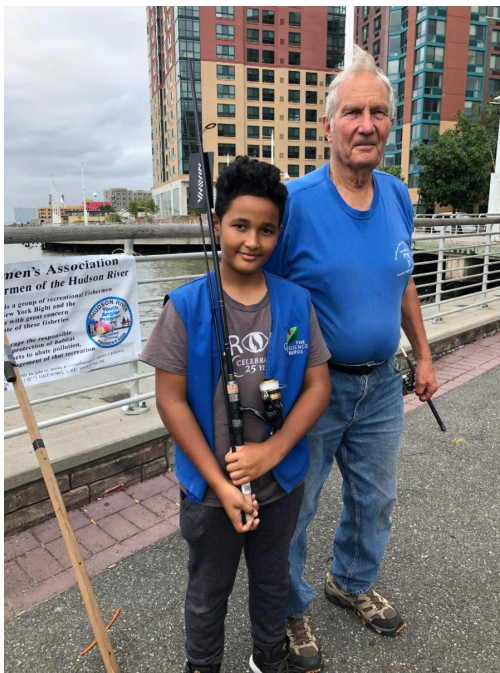

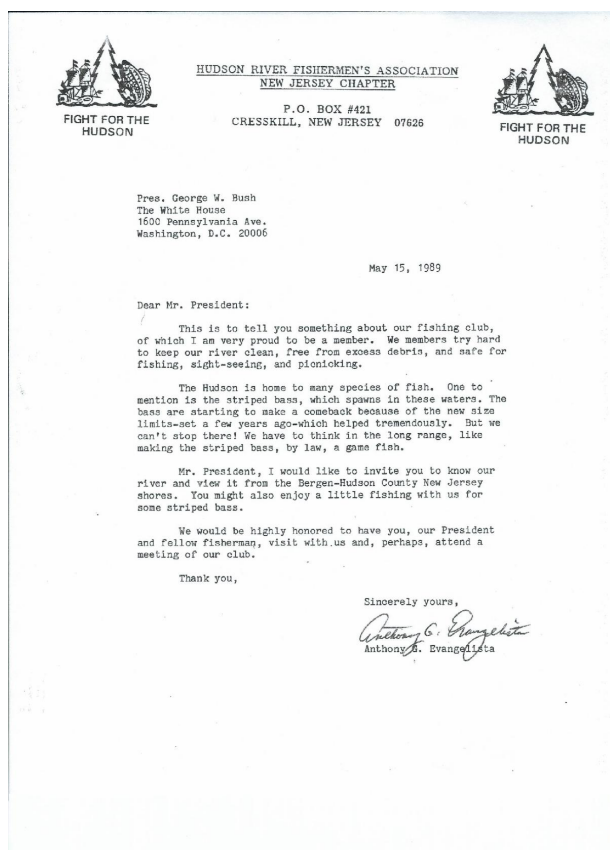

From Fish to Dish



Broiled Bluefish

Try this recipe for broiled bluefish and you may change your mind about their suitability for the dinner table. Like many

fish, the smaller ones taste best. For best results be sure to bleed the fish by cutting the gills and putting it on ice right away. Fillet the fish and trim away the skin and dark flesh. Put the fillets in a ZipLock bag and soak them in milk for a few hours in the fridge. Line a glass Pyrex square dish with sliced tomatoes and sliced onions. Lay the fillets on top and then season with salt & pepper and garlic powder. Then lightly sprinkle with olive oil and pour on a half cup of white wine. Pinot is good.



INGREDIENTS

- Cocktail/tailor bluefish fillets (1 to 3 lbs.)
- Milk
- Onions
- Tomatoes
- Olive Oil
- Salt, pepper, garlic powder
- White wine
